

## **ORDINANCE NO. 2019-06**

AN ORDINANCE OF THE CITY OF ALEXANDRIA, IN CAMPBELL COUNTY, KENTUCKY, AMENDING ORDINANCE 2019-03, THE CITY'S BUDGET FOR FISCAL YEAR 2019/2020, IN ORDER TO APPROVE THE SEWER FUND BUDGET, ACCORDING TO ATTACHED EXHIBIT "A".

BE IT ORDAINED BY THE CITY OF ALEXANDRIA, CAMPBELL COUNTY, KENTUCKY, AS FOLLOWS:

**SECTION 1.** Ordinance 2019-03 is hereby amended in order to amend the City of Alexandria's Fiscal Year Budget for 2019/2020, in order to approve the Sewer Fund Budget as set forth in Exhibit "A", which is attached hereto and incorporated herein by reference.

**SECTION 2.** This ordinance shall be effective upon its adoption, approval and publication according to law; this Ordinance may be published by Summary.

**SECTION 3.** All Ordinances or parts of any Ordinances in conflict herewith, to the extent of such conflict, if any, are hereby repealed.

<u>SECTION 4.</u> The foregoing Ordinance was introduced by Council Member Graus, was read, passed and adopted by the Council of the City of Alexandria, Kentucky, meeting in regular sessions on the 19<sup>th</sup> day of September, 2019, and on the 3rd day of October, 2019, with -6-Yes votes, -0- No votes, and -0- Abstentions, and was thereafter approved by the Mayor and ordered published in Summary according to law.
