PUBLIC HEARING

TO HEAR AND GATHER EVIDENCE AND PUBLIC COMMENT TO TAKE THE SENSE OF THE PUBLIC REGARDING THE PROPOSED TAX RATE WHICH WILL EXCEED THE COMPENSATING RATE, BUT THE PROPOSED RATE IS THE SAME AS IN THE PRECEDING YEAR.
