



ORDINANCE 2024-09

AN ORDINANCE OF THE CITY OF ALEXANDRIA, IN CAMPBELL COUNTY, KENTUCKY, RENAMING THE ISOLATED PORTION OF WASHINGTON STREET SOUTH OF EAST MAIN STREET TO BRADY WAY.

WHEREAS, there is a small portion of Washington Street in the City of Alexandria that is isolated south of East Main Street with no homes, businesses or properties with a Washington St. address as shown on Exhibit A; and

WHEREAS, the Delaney family has purchased the land at the end of Washington Street and are building their new home and have requested this isolated portion be renamed to Brady Way in order to remember their deceased son, Brady Delaney; and

WHEREAS, Brady's influence was felt throughout the community through his leadership on the CCHS Soccer team, his dedication to his friends, family, random acts of kindness and now the *BlikeB* Foundation which will bless the community with acts of service and scholarship opportunities for graduating seniors; and

WHEREAS, the City agrees that adopting the name Brady Way for this section of Washington Street will honor the memory of Brady Delaney and his impact to our community.

NOW, THEREFORE, IN CONSIDERATION OF THE FOREGOING, BE IT ORDAINED BY THE CITY OF ALEXANDRIA, CAMPBELL COUNTY, KENTUCKY, AS FOLLOWS:

SECTION 1: The portion of Washington Street in the City of Alexandria that is isolated south of East Main Street as shown on the attached map is hereby renamed: BRADY WAY.

SECTION 2: The Mayor, City Administrator, City Clerk and/or City Attorney are hereby authorized and directed to take whatever action necessary to carry out and effectuate the street name change adopted herein.

SECTION 3. This Ordinance shall be effective upon its adoption, approval and publication according to laws; this Ordinance may be published by Summary.

SECTION 4. Should any section, clause, line, paragraph, or part of this Ordinance be held unconstitutional or invalid for any reason, the same shall not affect the remainder of this Ordinance.

SECTION 5. All Ordinances or parts of any Ordinances in conflict therewith, to the extent of such conflict, if any, are hereby repealed.

SECTION 6. The foregoing ordinance was introduced by Council Member Robert Strong, was read, passed and adopted by Council of the City of Alexandria, Kentucky, meeting in **regular sessions on the 5th day of September 2024, and on the 19th day of September, 2024,** with 6 yes votes, 0 no votes, and 0 abstentions, and was thereafter approved by the Mayor and ordered published in Summary according to law.
